



SCHOLARSHIP ELIGIBILITY REQUIREMENTS

1. Applicants must be a senior in high school residing within the Fulton Bank footprint (Pennsylvania, New Jersey, Delaware, Maryland, District of Columbia and Virginia).
2. Applicants must be accepted and in the process of enrolling in an accredited two-to-four-year undergraduate degree program.
3. Applicants must state their intent to major in a STEM field.
4. Applicants cannot be a dependent child of an active Fulton Bank, N.A. or Fulton Financial Corporation employee. **Note:** *Children of active Fulton Financial Corporation and Fulton Bank, N.A. employees, Fulton Bank or Fulton Financial Directors or Fulton Bank Advisory Board members are not eligible for this scholarship opportunity.*
5. Applicants must complete the application process by submitting to WITScholarship@fultonbank.com the following documents:
 - ✓ A completed Fulton Bank Women in Technology Scholarship Application;
 - ✓ A copy of an official document that demonstrates current home address – this can be a driver's license or other official document;
 - ✓ Two (2) letters of recommendation from individuals *other than family members*;
 - ✓ Original high school transcripts;
 - ✓ Acceptance and confirmation of plans to attend school in the 2025/2026 academic school year from the accredited undergraduate school. This can include assigned student ID or letter from the school.

The judging of scholarship applications will be based on multiple factors including academic achievement as detailed on high school transcripts (showing grade point average), extracurricular activities, leadership qualities, honors or awards, work experience, a written essay and two letters of recommendation.

All applications *and* appropriate supporting documentation must be received by
Friday, May 9, 2025
in order to be considered for a scholarship award.
